Mayor Redfish appointed Keith Wendland to a one-year term of office for Ward 3. Motion was made by Lundquist, seconded by Bunker to approve this council seat appointment. All in favor—Carried.

Council Members Amiel Redfish, Curt Lundquist, Terry Rowbotham, Keith Wendland and Jared Steffensen took their oaths of office to begin serving a new term of office as administered by Todd Wilkinson.

Additions to Agenda: Review Health Insurance Quote

The council reviewed the variance request from Ken Crabtree. Motion was made by Rowbotham, seconded by Bunker to approve the variance as recommended by the Zoning Commission and also approve the building permit request for the 20 X 24 addition and 12 X 18 deck to the current residence. All in favor—Carried.

The council reviewed the building permit submitted by Ronald Brown for a chain link fence for his property located at Lot 1, Block 1, County Auditor's Plat—105 East Oak Street to keep dogs off his property, privacy and security. As presented it does not follow the zoning ordinance; however, Terry Rowbotham volunteered to meet with the applicant and explain how the fence would need to be installed and if the height of the fence and move it back to be within the pins it was permissible. Motion was made by Rowbotham, seconded by Steffensen to approve the building permit if these changes to the plan are made when installing the fence. All in favor—Carried.

The bid opening for the substation transformers was held as advertised on April 14, 2016. Two bids were received: CG Power Systems USA Inc, Washington, MO submitted a base price of \$648,600.00 for both units with a total evaluated price of \$774,216.00 and Wesco Distribution Inc, Sioux City, IA submitted a base price of \$717,670.00 for both units with a total evaluated price of \$878,590.00. DGR Engineering gave their recommendation to award the substation transformer bid to CG Power Systems USA Inc. Motion was made by Bunker, seconded by Rowbotham to award the bid to CG Power Systems USA Inc. All in favor—Carried.

The bid opening for the street light materials was held as advertised on April 15, 2016. Only one bid was received from Wesco Distribution Inc, Sioux City, IA in the amount of \$30,883.00. Due to the fact that this bid was lower than the engineer's estimate—Motion was made by Lundquist, seconded by Wendland to award this bid to Wesco Distribution Inc for \$30,883.00. All in favor—Carried.

The City will be checking to see the number of additional street lights that will be needed if the street is bid out in the Industrial Park and they will also be ordered under this bid.

DGR Engineering had asked for quotes to do soil borings at the site for the new substation. They received 3 quotes:

DGR recommends that the City accept the quote from American Engineering Testing, Sioux Falls, SD in the amount of

ORDINANCE #549

CHAPTER II-3 Electricity

SECTION 1. CONTROL. The sale and distribution of electrical current or electrical energy within the city of Arlington shall be exclusively under the supervision and control of the city of Arlington.

SECTION 2. INSTALLATION. All electrical wiring and the installation of electrical machinery or apparatus in the city of Arlington shall be installed and constructed according to the Code of the National Board of Fire Underwriters as the same may be revised from time to time. Any electrical wiring, machinery or apparatus which does not conform to such requirements or which may, in any manner, be deemed unsafe by the superintendent in charge of the electrical distribution system may be disconnected by him and the same shall not be reconnected until it shall have been inspected by him and shall conform to such code.

SECTION 3. ONE USER. No more than one user of electrical energy for any purpose whatsoever shall be supplied from any one meter.

SECTION 4. APPLICATION. Any person desiring to be connected with the electricity shall make applications therefore to the City Finance Officer and shall pay an immediate deposit of \$150.00. The superintendent in charge of the electrical distribution systems shall thereupon connect such premises with electricity and shall install the meter therein, which meter shall at all times be available for reading and inspection by the City of Arlington and which meter shall remain the sole property of the City.

SECTION 5. RATES. The current rate schedules as set by city ordinance shall apply for electricity metered for residential, residential-commercial, commercial and large power demand users.

SECTION 6. PAYMENT. Monthly statements or billings will be furnished each customer the first of each month for utility bills; said bills shall be payable no later than the 20th day of said month. In the event said charges are not paid the statement or billing shall be deemed delinquent. All delinquent billings shall have added to the next month's billing a late charge of \$25.00 per month. Every customer who is more than two months delinquent shall be subject to discontinuance of service. In such event the customer shall be given notice and opportunity to be heard before the town board as to why the service should not be disconnected. Notice shall be in writing and shall be mailed by first class mail, postage prepaid, to the customer, at his last known address. The notice shall be mailed at least four days prior to the date set for hearing. After said hearing, the utility board shall have the power to (a) disconnect the service; (b) continue the service subject to any terms or conditions which may be imposed by the board regarding payment of the delinquencies.

SECTION 7. RESPONSIBILITY. The city of Arlington shall in no manner whatsoever be liable to any user or to any person for current failures.

SECTION 8. DELINQUENT PAYMENT. The minimum of \$100.00 will be accepted as payment on a delinquent bill or if such delinquent bill is less than \$100.00, the full amount must be paid.

SECTION 9. DELINQUENT BILLS. The owner of the property, which is served by municipal utilities from the city, shall, as well as the lessee or occupant for the property, be liable to the city for the utility bills, which may be recovered in an action against such owner, lessee, or occupant or against any or all of them, jointly or severally. The provisions contained shall equally apply to the owner of the property as they do to the consumer/lessee or occupant.
