Adam Hanson, Banner Associates, met with the council to explain to them the process that would be needed to go thru in order to take out the current wall between the community room and the fire hall. A temporary wall will need to be put in place while the footings and pillars are installed for the bays for the fire equipment. He suggests that the project not be started until spring when there is no danger of snow weight on the roof. The plan is to advertise for quotes for the project in January and open quotes in February.

The following demolition permits were filed for approval: Sons of the Legion—tear down the current structures at Lots 9-10, Block 3, Original Plat to the City of Arlington—118 & 120 South Main Street. Motion was made by Lundquist, seconded by Achterberg to approve this permit. All in favor—Carried. Diane Krimbill—tear down and remove existing house and out building plus remove damaged and dead trees at Lots 3-4, Block 13, County Auditor's Plat of Outlots in Arlington. Motion was made by Steffensen, seconded by Lundquist to approve this permit. All in favor—Carried.

Marshall Mix reported that ACDC had received a \$5000 grant from Heartland Consumer Power District that will be used to repair the sign at the Industrial Park.

Motion was made by Lundquist, seconded by Achterberg to approve the employee overtime and police report. Also, Matthew Asmussen has completed his 6 month probation period and is due for his \$2.00 raise. All in favor—Carried.

Motion was made by Steffensen, seconded by Rowbotham to approve allowing Sue Falconer to carry over 4 vacation days into next year. All in favor—Carried.

The council reviewed the Revenue/Expense, Cash & Utility Reports.

Motion was made by Johnson, seconded by Lundquist to approve writing off the following amounts for the years of 2016 and 2017—Utility Bills \$7052.61 and Ambulance Bills \$14,412.83. All in favor—Carried.

Supplemental Appropriation Ordinance #557 received the second reading and on Motion by Steffensen, seconded by Rowbotham same was approved with all voting Aye—Carried.

AN ORDINANCE SUPPLEMENTING THE ANNUAL APPROPRIATION ORDINANCE #552

PROVIDING REVENUE FOR INDESPENSABLE FUNCTIONS OF CITY GOVERNMENT

BE IT ORDAINED BY THE CITY OF ARLINGTON, KINGSBURY COUNTY, SOUTH DAKOTA:

SECTION 1. It is hereby deemed necessary that there is hereby appropriated for the objects and purposes herein specified to pay the necessary expenses and liabilities of the government of the City of Arlington, Kingsbury County, South Dakota, with unencumbered surplus funds from city owned utilities during the fiscal year 2017 as follows:
