April 16, 2018

The City Council met in regular session in the Council Room in the Municipal Building. Present on Roll Call were Mayor Amiel Redfish, and Council members: Curt Lundquist, Terry Rowbotham, Garth Johnson and Cory Falconer. Absent: Jesse Steffensen and Rob Archterberg.

The Finance Officer advised that she had received an additional application for employment at the bath house for this summer. The council voiced their opinion that 3 individuals had already been hired for that position and felt that was a sufficient number to cover that area and no one else would be hired.

Beth Niemeyer, Banner Associates, had furnished the Project Manual for the Arlington Street Improvements for 2018 for their approval and signature. Todd Wilkinson reviewed that document and advised that the City should accept them as presented.

Motion was made by Falconer, seconded by Rowbotham to accept the Project Manual for the Arlington Street Improvements for 2018 and authorized the Mayor to sign these documents. All in favor—Carried.

The finance office had received a question from a property owner regarding installation of an egress window at his home. The problem is that he would need to go into his neighbor's property in order to install the well. Todd Wilkinson advised that this is not something that the city can get involved with and that he would either need to work out an arrangement with the neighbor, or install the window on another side of the home.

The Police Report for March was received too late for the April council meeting. So, it was presented at this time. Motion was made by Johnson, seconded by Lundquist to approve the report. All in favor—Carried.

The Mayor had received an email regarding an incident involving a couple of children and asking the City if they could request that something be done with the property to avoid any injuries in the future. The council will do some checking as to exactly where the incident happened and notify the property owner as they did not know if they were aware of the occurrence.

The Mayor stated that he wants to begin holding task force meetings for future planning for the City. He would like to include members from ACDC, the school, the city council and add on others that are interested. He would like to come up with a 5 year and a 10 year plan for city improvements. However, it will also need to be determined where the funding will come from for the projects.

The election board for April 10, 2018 met earlier to open and count a provision ballot that had been determined that the residency requirement was in compliance.
