Travis Steffensen met with the city council to give them an update on the plans for the Field of Grace Concert to be held on August 18th. He asked the council for permission to install a permanent 16-20 X 8 ft billboard by the scoreboard at the ball field advertising the concert and acknowledging the sponsors. Motion was made by Johnson, seconded by Achterberg to approve installing this billboard as Travis has already gotten permission from the DOT to place it at this location. All in favor—Carried.

Representatives from the Fire Dept requested time with the council with a few requests—they are concerned about water damage to the sheet rock and wondering if metal should be placed over it; they were requesting ceiling fans to circulate the air; and they are concerned about the conditions of the ground just outside the west overhead door—since they may end up using that door. The Mayor advised that the items it would be considered.

Jay DeVries was unable to meet with the council, however; he advised the Mayor that the Ambulance Service is looking for a demonstrator model ambulance to purchase. However, due to a fire production has currently stopped on new ambulances—so the purchase will not take place this year.

Now was the time for the hearing of the Special One (1) day Malt Beverage applications, Spiking Permit application as advertised on June 20, 2018.

Motion was made by Johnson, seconded by Falconer to approve these special licenses for Arlington Days. All in favor—Carried.

With the changes made by the Legislature in the last session—there is a variation from the state law and the city ordinance. Arlington currently does not allow the sale of liquor on Christmas. The council decided not to make any change to the ordinance at this time.

Penny Rinderneck requested time to discuss her alley and street with the council. Penny was wondering if some dirt could be put in the ruts in the alley and the gravel that had just been put on her street could be spread out more evenly. Marshal advised that it had just been put down that day and the city will be going over it with the blade. She also wanted to know if something could be done about the plugged culverts in that area. The next time that the jetter company is in town—Marshal will have them look at them.

Mike Quam wanted to talk to the council about the possibility of installing drain tile along South 3rd Street. The council advised that they would do some checking on this project and Mike was going to look into current prices to install the tile.

Jeremy Quam—Privacy Fence @ E ½ Lot 12 & All Lot 13 in Block 8, Leiske's 3rd Addition—514 S 4th Street. Motion was made by Falconer, seconded by Lundquist to approve. All in favor—Carried.

Prairie Ag Partners—Warehouse & Seed Bins at Lot 12, Railroad Addition—105 N Main Street. Motion was made by Steffensen, seconded by Achterberg to approve since they had already obtained a variance. All in favor—Carried.

The only item on the ACDC Report was an invitation to the council members to attend the annual meeting on July 10th @ 1481 Grille.

Motion was made by Lundquist, seconded by Steffensen to approve the Employee Overtime & Police Report. All in favor—Carried.

Motion was made by Lundquist, seconded by Falconer to hire Hayley Halverson as a Swimming Lesson Instructor @ \$12.00/Hr. All in favor—Carried.

The council reviewed the Revenue/Expense and Cash Reports. There was no Utility Report available.

Todd Wilkinson presented a Public Comment Policy for their approval in order to be in compliance with the new ruling from the legislature. This policy allows for anyone to attend the council meeting and have a 3-minute time period to speak to the council during a designated time on the agenda. However, there will be no action taken on an item since it was not listed on the published agenda.

Motion was made by Lundquist, seconded by Achterberg to approve the Public Comment Policy as presented. All in favor—Carried.

Nancy Miklos spoke during the Public Comment period to ask the council about the possibility of closing off a portion of the alley between the Citizens State Bank parking lot and the Medical Clinic during the vendor fair for Arlington Days. Since the parade will be coming thru Birch Street—it cuts down on the amount of space for vendors. The council agreed that the alley can be closed off from the driveway for the drive up window at the bank to Birch Street.

Beth Niemeyer and Marshal Mix spoke to the council about improvements to Adams Street. Earlier it had been discussed to tile in that area—however, the City cannot obtain an easement for that plan to improve the drainage. So, the new plan is to put a fabric down on Adams Street and then use the gravel reclaimed from the street projects to build up that street if something can be worked out with the contractor. This will be addressed during the pre-construction meeting.

The Heartland Summer Conference will be held on July 10th with the Mayor, Marshal, Matt and Sue attending. The County Contract Law Meeting will be held on July 12th with Garth Johnson and Cory Falconer attending.

Motion was made by Johnson, seconded by Falconer to enter into executive session at 8:35 P.M. for personnel matters, contract issues and possible litigation. All in favor—Carried.

Motion was made by Lundquist, seconded by Achterberg to come out of executive session at 9:20 P.M. All in favor—Carried. No further action taken.

Motion to adjourn was made by Steffensen, seconded by Rowbotham. All in favor—Carried.
