Motion was made by Lundquist, seconded by Falconer to adopt Resolution #2579 as follows:

# **RESOLUTION #2579**

BE IT RESOLVED, that \$7,692.31 be transferred from the 2<sup>nd</sup> Penny Sales Tax Fund to the General Fund for gravel. All in favor—Carried.

Time for Public Comments-None.

Two company representatives from Bowes Construction met with the council to discuss the unfinished street project. They advised that the "patch areas" that are to be done by the school will be taken care of prior to the first day of school. Also, as soon as the concrete work is completed they will be in Arlington and will finish the street work and will not leave until the project has been completed.

Jay DeVries met with the council on behalf of the Arlington Ambulance Service. There was a discussion about the equipment that the squad is still looking at purchasing or leasing so that both of the ambulance units have the ability to take care of any upcoming runs. Jay advised that they recently received notification that they had been awarded a \$2500 grant, but will not hear on the FEMA grant for a couple of months. There will be some more contacts made regarding the sale of the surplus ambulance unit.

The finance office had received two building permit applications for the council to review and approve. David & Janelle Virchow, Lot 17, Block 2, Original Plat—207 North 3<sup>rd</sup> Street—to move in a 10 X 20 shed in their back lot and Trevor Sikkink, Lot 3, Block 1, Johnson's 2<sup>nd</sup> Addition—101 Park Circle—to put up a privacy fence in their back yard. Motion was made by Johnson, seconded by Falconer to approve both of the building permits. All in favor—Carried.

Eldon Smith presented a plat map for the council's approval. He is re-platting his duplexes in order that he can sell one of the units.

Motion was made by Lundquist, seconded by Falconer to adopt Resolution #2580 as follows with all in favor:

Gary Schumacher, Kingsbury County Veterans Services Officer, met with the council to inform them of a ceremony which will be held on Tuesday, August 20, 2019 at 1:00 P.M. at the Kingsbury County Courthouse to issue a proclamation supporting recipients of the Purple Heart medal and to recognize the recipients. He asked that the council adopt a Proclamation regarding this program. Motion was made by Johnson, seconded by Lundquist to adopt the following proclamation with all in favor.

#### KINGSBURY COUNTY, SOUTH DAKOTA

# A PURPLE HEART CITY

Whereas, the people of this City of Arlington, South Dakota have admiration and the upmost gratitude for all the men and women who have selflessly served their country and community in the Armed Forces; and

Whereas, veterans have paid the high price of freedom by leaving their families and communities and placing themselves in harm's way for the good of all; and

Whereas, the contributions and sacrifices of the men and women from Arlington, South Dakota who served in the Armed Forces have been vital in maintaining the freedoms and way of life enjoyed by our citizens; and

Whereas, many men and women in uniform have given their lives while serving in the Armed Forces; and

Whereas many citizens of our community have been awarded the Purple Heart Medal as result of being wounded while engaged in combat with an enemy force, constructed as a singularly meritorious act of essential service; and

Whereas, August 20, 2019 has officially been designated as the day in Arlington, South Dakota to remember and recognize veterans who have been awarded the Purple Heart medal.

NOW, THEREFORE, BE IT RESOLVED that the City of Arlington, South Dakota hereby proclaims Arlington, South Dakota as a Purple Heart City, honoring the service and sacrifice of our nation's men and women in uniform wounded or killed by the enemy while serving to protect the freedoms enjoyed by all Americans.

Marshal Mix advised that they are in the process of installing the transformer at the ball park and it will be operational in time for the Field of Grace concert.

On behalf of the ACDC, Marshal advised that a lot in the Arlington Industrial Park has been platted and asked that the council approve the new plat map. Motion was made by Steffensen, seconded by Falconer to adopt Resolution #2581 as follows with all in favor:

WHEREAS, Marshal Mix, President of Arlington Community Development Corporation, owner of the hereinafter described real property have submitted to the governing board, a proposed Plat of Block 8, in the Arlington Industrial Park in the City of Arlington, Kingsbury County, South Dakota, and the Governing Body of said City of Arlington, having examined the proposed plat and it appearing that all municipal taxes and special assessments, if any, upon said plat and survey have been executed according to the law.

NOW, THEREFORE, BE IT RESOLVED THAT said plat and survey by and are hereby in all things accepted and approved.

The Council reviewed the correspondence that had been received back from Roselyn Sjolie regarding spraying the evergreen trees at the cemetery. After reviewing the information, Motion was made by Lundquist, seconded by Johnson to authorize her to spray the trees annually. All in favor—Carried.

Motion was made by Steffensen, seconded by Johnson to approve the employee overtime, library and police reports. All in favor-Carried.

The council reviewed the Revenue, Expense, Cash Reports and two months of Utility Reports. Marshal advised that a water leak had been found under a resident's home. That line is being abandoned and the property owner is having a service line installed. The water break was before the meter, therefore it was not showing up on the monthly utility bills.

The Deputy from the Kingsbury County Sheriff's office attended the meeting and was asked about the warning tickets that had been issued for unlicensed units. He stated that many of the vehicles were no longer in town and that most of the issues have been addressed. He did not know how many tickets had been written. The council then visited with him about the unlicensed drivers operating various types of units on city streets. Many of these drivers are underage and the council wants them to be given at least a warning ticket as they are concerned that someone will be hurt and there are also property owners who are concerned that they are traveling on private property.

Motion was made by Johnson, seconded by Falconer to enter into executive session at 8:22 P.M. for contract matter, possible litigation and a personnel matter. All in favor—Carried.

Motion was made by Steffensen, seconded by Johnson to come out of executive session at 8:35 P.M. All in favor—Carried.

Scott Mohror, Banner Associates, met with the council to discuss the unfinished street projects and also the need for an amendment for the engineering contract for the project. Banner is unable to bill the responsible party for the engineering fees unless there is a current contract.

Motion was made by Lundquist, seconded by Johnson to approve the Amendment to Owner-Engineer Agreement— Amendment No. Two effective August 5, 2019 for the Arlington Street Improvements 2018 Project. All in favor—Carried.

Motion was made by Lundquist seconded by Falconer to approve the first reading of Ordinance #570 for the 2020 Budget in the amount of \$2,942,695.00—however, the Finance Officer reminded the council that they can make changes to the budget prior to the 2<sup>nd</sup> reading; but that it must balance. All in favor—Carried.

The City has received complaints of individuals blowing their grass clippings out into the city streets which can cause problems with the storm sewer and can also be a safety hazard for motorcycle riders. There is an ordinance against blowing grass clippings in the street and has a \$100 fine which could be assessed to individuals who are not in compliance with the ordinance.

The Finance Officer advised that the current ag land leases are done the end of 2019. Ads will be run in the paper for bids for the three leases and they will be opened at the September council meeting.

There will need to be a special meeting on August 19<sup>th</sup> in order to act on a malt beverage license for the legion for the end of August. Also, the September council meeting will be held on Tuesday, September 3<sup>rd</sup> due to the Labor Day holiday.

The council instructed the finance officer to obtain more information on a fall city cleanup day, regional code enforcement and radar speed signs.

Gene Wiehr is no longer able to work for the City. Two applications had been received to mow the parks, etc. Motion was made by Steffensen, seconded by Falconer to offer the mowing position to Larry Stamer at \$12.00/Hr to begin immediately. All in favor—Carried.

Motion to adjourn was made by Lundquist, seconded by Falconer. All in favor-Carried.
