Motion was made by Rowbotham, seconded by Falconer to approve. All in favor—Carried.

A property owner contacted the city office and wanted to swap his cleaning off the sidewalk in Maxwell Park for the bill for mowing his rental property lot. The council did not approve of the idea and the mowing bill is due. On another mowing matter, the property owner protested paying for mowing his empty lot; however, the council advises that if the city mowed the lot—the bill is due.

The finance office has received a couple of calls inquiring if the city has a storm shelter for people in town in the event of a tornado, etc. The city no longer has excess to a location.

There are a couple of individuals who are requesting a special meeting on July 13th to review variance requests. It appears that a quorum is available—so that meeting will be scheduled.

Motion was made by Lundquist seconded by Achterberg to enter into executive session at 7:40 P.M. to discuss a contract matter and personnel issue. All in favor—Carried.
