The City Council met in special session pursuant to notice as required by law: Present on Roll Call were Mayor Curt Lundquist, and Council Members: Terry Rowbotham, Rob Achterberg, Jesse Steffensen and Garth Johnson. Absent: Cory Falconer and Terry Mutziger.

The purpose of the meeting was to discuss and decide upon Health Insurance for full time city employees.

Discussion was held and upon motion by Steffensen, seconded by Johnson, the city will move from plan B to Plan D for full time employees, with a \$0.75 pay raise beginning January 1, 2022, to compensate the increase in deductibles and co-insurance. All in favor—Carried.

Motion was made by Johnson, seconded by Achterberg to approve Resolution #2626 to amend Ordinance #378, regarding parking ticket charges.

Resolution #2626

WHEREAS, the City of Arlington has adopted Ordinance No. 378 Entitled An Ordinance Regulating Parking of Vehicles of Any Type Either Parallel with the Curb or Angular Thereto Shall Be Prohibited During Snow Removal and Penalties for Violations Thereof; and

WHEREAS, the City has established a fine schedule for violation of Ordinance No. 378.

Now Therefore Be it Herby Resolved

- 1. That for a first offense prohibited parking violation pursuant to Ordinance No. 378 the fine shall be established at twenty-five (\$25.00) dollars.
- 2. That for a second offense prohibited parking violation pursuant to Ordinance No. 378 the fine shall be established at fifty (\$50.00) dollars.
- 3. That for a third offense prohibited parking violation pursuant to Ordinance No. 378 the fine shall be established at one hundred (\$100.00) dollars.
- 4. For all violations in excess of three violations of Ordinance No. 378 in a one (1) year period, the individual committing the offense shall be required to appear in court and be subject to such fine and/or improvement as Court may adjudicate.
- 5. In the event the City seeks enforcement of the violation tickets through filing the Complaints with the Clerk of Courts, the court costs in effect at the time of sentencing shall be added to an become a part of the penalties assessed by the Court.
- 6. For violation not initially submitted to the Clerk of Courts for enforcement the individual committing the offense shall have the opportunity to pay the fine to the City of Arlington Finance Officer if the fine is paid within 10 days of the issuance of the ticket or complaint.
