The City Council met in special session pursuant to notice as required by law: Present on Roll Call were Mayor Curt Lundquist, and Council Members: Terry Rowbotham, Rob Achterberg, Cory Falconer, Terry Mutziger and Garth Johnson. Absent: Jesse Steffensen.

The purpose of the meeting was to discuss amending the Water and Wastewater Funding Application and have the second reading of the Election Ward Changes.

Discussion was held and upon motion by Rowbotham, seconded by Mutziger, the council decided to amend the Water and Wastewater Funding Application to include the ARPA funds. Including this amount will double the amount we receive from ARPA. All in favor—Carried.

## ORDINANCE NO. 590

AN ORDINANCE REPEALING AND REPLACING Chapter I-3, Section 11 of the Arlington City Code defining Boundaries of Wards I, II and III.

Section 11.1. Ward One: All that property within the City limits North of US Highway 14; all that property within city limits lying east of US Highway 81/US Highway 14; and all that property lying between US Highway 14 and Birch Ave bordered by US Highway 81/US Highway 14 on the East and 4<sup>th</sup> Street on the West.

Section 11.2. Ward Two: All that property within the City limits lying South of Hickory Street and West of Spruce Street; all that property within City limits lying south of Birch Ave, West of US Highway 81/US Highway 14, East of Spruce Street (from the south boundary of City Limits to its intersection with 3<sup>rd</sup> Street) and east of 3<sup>rd</sup> Street (between Spruce Street and Birch Avenue); also specifically including Block 1 of Chandler's 1st Addition to the City of Arlington; also specifically including all of Block 7 of 2<sup>nd</sup> Railroad Addition to the City of Arlington; and specifically including all of Block 7 of Keep's 1<sup>st</sup> Addition.

Section 11.3. Ward Three: All that property east of City limits lying west of Spruce Street, and between Hickory Street and 3<sup>rd</sup> Street, but specifically excluding Block 1 of Chandler's 1st Addition to the City of Arlington; all that property east and south of City limits between US Highway 14 and 3<sup>rd</sup> Street, but specifically excluding: all of Blocks 7 and 8 of 2nd Railroad Addition to the City of Arlington and specifically excluding all of Blocks 7 and 8 of Keep's 1st Addition.

Section 11.4. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.
