ORDINANCE #592

An Ordinance amending Section 5. Rates, Small Commercial Service, of existing Ordinance #546 to read as follows:

Small Commercial Service

APPLICABLE TO: Any commercial, industrial, city, or farm load within the service territory of the City of Arlington Electric Utility, for all purposes, where the energy usage with a monthly average (in a consecutive twelve month period) does not exceed 5,000 kWh.

SERVICE AVAILABLE: Single-phase, 60 hertz, 120/240 volt, 400 amp max., 3-wire, single meter; or three-phase, 60 hertz, 240/120V, 208Y/120V, or 480Y/277V, 4-wire, single meter.

PROMPT PAYMENT PROVISIONS:

All charges are net. If the bill is not paid or mailed and postmarked by the 20^{th} day of the month following the billing date, a late payment charge of \$25.00 will apply. If the 20^{th} of the month falls on a Saturday, Sunday, or Holiday, the due date will be the next working day.

SALES TAX:

Sales tax to be added to all electric bills so as to be in compliance with the provisions of the laws of the state of South Dakota.

ENERGY COST ADJUSTMENT:

The City of Arlington Electric Utility may, at its discretion, implement an energy cost adjustment to compensate the City of Arlington Electric Utility for variations in the cost of purchased power. At the time the adjustment is implemented, the calculation used to arrive at the adjustment will be developed, and the adjustment will be applied to all kWh billed by the City of Arlington Electric Utility.
