Motion was made by Falconer, seconded by Sundberg to approve payment of \$3,750.00 for the vacation guide ads. All in favor—Carried. 7:11 PM – Terry Rowbotham now present.

Motion was made by Achterberg, seconded by Johnson to approve Pay Request #1 from DeBoer Construction for the Birch Street project. All in favor—Carried.

Motion was made by Mutziger, seconded by Achterberg to adopt Resolution #2654 as follows:

RESOLUTION #2654

BE IT RESOLVED, that \$311,757.75 be transferred from the 2nd Penny Fund to the General Fund for payment of the bill to DeBoer Construction for the first pay request for the Birch Street project. All in favor—Carried.

Mike Fuhr asked the Council if the re-routing of the sewer project can be done, what those costs would be, who would pay for the change, and other easement and concrete questions. He discussed the concrete repair that would be needed if we moved forward as currently designed and the credits that would be taken off the original price as this total amount would be within \$2000. Beth Neimeyer from Banner said she would get us the exact amount (additions and subtractions) and the Council decided that if it was within the \$2000, the city would pay for the difference.

Beth also informed the Council that the yard hydrant, water line, storm drain, fabric, and base course were all installed on Birch Street. Lot 3 has requested a larger waterline to which the Council said the owner will need to pay for the difference. As Johnson also owns a lot there, he requested a larger waterline as well, paying the difference. She also said that the approach aprons were not included in the bid and that the total for those additions will be approximately \$5000.

It was moved by City Council Member Achterberg and seconded by City Council Member Johnson that the following Proposed Resolution be passed and adopted:

WHEREAS, to facilitate this improvement a special assessment is necessary for curb and gutter improvements to be

made;

NOW THEREFORE BE IT RESOLVED that it is necessary to improve Birch Street adjacent to the above described property located in the City of Arlington, in Kingsbury County, South Dakota. That the nature of such improvement is to regrade, pave, and install curb and gutter along said street in accordance with the plans and specifications on file in the Office of the City Finance Officer of said City, which specifications are available for inspection by any person interested therein, or affected thereby, and the same by this reference, and made a part hereof and incorporated herein. That the materials to be used for said improvements are oil, gravel, cement and other materials necessary for the regrading, paving and installation of curb and gutter to the above described premises. That only the cost associated with the installation of the curb and gutter is to be involved in this special assessment as the City of Arlington will be responsible for all other costs associated with the street improvements. That the estimate of the cost per linear foot to the adjoining property owners for curb and gutter installation is estimated at \$23.00. That the classes of the lots to be assessed are residential. That the cost of the improvement will be proportioned to the property fronting and abutting upon said improvement by special assessment for the cost of the curbing and gutter upon said improvement by special assessment for the cost of the curbing and gutter and all remaining costs shall be paid by the City out of general funds.

The second reading of Ordinance #614 to amend the Outdoor Fires section of the ordinance book to remove "incineration, burn barrel" from 13-1-4: A. ii. was held. Motion was made by Rowbotham, seconded by Sundberg to amend the Ordinance to read as stated below. All in favor—Carried.

ORDINANCE #614

An Ordinance Amending Ordinance #459 Titled An Ordinance Amending Ordinance #442 and Ordinance #VI-2 Entitled: Arlington Ordinance Article I, Section 4, Outdoor Fires, City of Arlington, County of Kingsbury, State of South Dakota. Be It Ordained by the City of Arlington, South Dakota, that Section 4 be amended to read as follows:

<u>Section 4. OUTDOOR FIRES</u>. It shall be unlawful and is hereby declared a nuisance to burn within the City limits. The Arlington Fire Department shall be called to extinguish all fires burning within the city limits. If it is deemed that a fire was started intentionally, the person responsible for starting the fire shall be charged and responsible for the cost of extinguishing as determined by the Arlington Fire Department.

A. Campfires and bonfires which are used solely for recreational purposes, for ceremonial occasions, or for outdoor preparation of food; provided that such campfire or other fire is started and maintained so as to prevent the escape of any burning substance, sparks, flames or hot ashes and so as to prevent the smoke from such campfire or other form from traveling to any occupied structure not owned by the person starting the fire.

- i. Campfire shall be defined as: The recreational burning of materials other than rubbish where fuel being burned is contained in an approved fireplace and with a total fuel area of 2 feet or less in diameter and 1 foot or less in height for pleasure, religious, ceremonial, cooking or similar purposes.
- ii. Bonfire shall be defined as: The recreational burning of materials other than rubbish where fuel being burned is not contained in an outdoor fireplace, barbecue grill or barbecue pit and with a total fuel area of 5 feet or less in diameter and 3 feet or less in height for pleasure, religious, ceremonial, cooking or similar purposes.
- B. Any person desiring to utilize a campfire and/or bonfire shall apply for a permit to be issued by the City Council. A permit fee of \$10.00 shall be paid upon permit application which fee is not refundable regardless of issuance of the permit. The City Council may deny any permit application if deemed necessary for the protection of the health, safety and general wellbeing of the residents.

Public Comments – Members of the Student Council requested permission to whitewash the streets around the school (as they did last year) for homecoming week. The Council approved that request.

Weeds: Community members, parents, and students supporting the FFA spoke to the Council about being contacted by a neighbor for having weeds in the property they own and use for hay ground. They received a letter from the Kingsbury County Weed & Pest Supervisor saying they should cut it twice a year (which they do), or do a chemical spray down with 2-4-D B. They also noted that the neighbor is mowing a path through the property in which they have not received permission to do. Wilkinson will send a letter to the neighbor.

Motion was made by Rowbotham, seconded by Falconer to go into executive session at 7:57 PM for contract issues. Mayor Lundquist declared out of executive session at 8:02PM.

Motion was made by Mutziger, seconded by Johnson to approve the first reading of the new/updated zoning ordinance book, Ordinance #616. All in favor—Carried.

Liquor tax was discussed, and the Finance Officer was asked to contact Pierre to see what information they could provide to determine the revenue that may be gained from increasing the malt beverage tax and what the 3rd penny sales tax can be used for. Motion was made by Mutziger seconded by Johnson to approve the first reading of the mausoleum addition to the cemetery portion of the ordinance book.

Garbage bids were opened August 7th with 2 bids received. Motion was made by Achterberg, seconded by Falconer to accept the bid from COOK's for \$13.65 per household, plus tax and \$7.00 per additional can/tote. All in favor—Carried.

The corner of Hickory St and Adams St. was discussed regarding some speeding around the corner which can at times throw rocks in people's yards, as well as a light needed at that intersection. A stop sign was discussed, but with there only being one direction to go at this time and the addition of the asphalt up to Adams, we are hopeful that will take care of the issue. The city will be installing a light at that intersection.

Wendland, Lot 2, Block 4, Lieske's 2nd Addn (205 S. Willow) - remove existing deck and add new larger one. 3B/Robert Butler, S2 Lot 8 & all Lot 9, Block 3, Chandler's 1st Addn. (603 S. Highland St.) - fence; Robert Zeller Lot 8, Block 1, Ecklein's 1st Addn. (315 S. Main St.) - fence, Warren & April Rusche, Lot 7 exc. Lot H 1, Swedlund Addn. 1-110-53 Lieske's 4th Addn. (507 W. The ambulance had requested a black & white copier/fax combo and the Council told the finance officer that it would come out of their budget, so they should decide which one they would prefer. The Finance Officer will contact them and let them know.

County Contract Law was discussed, and a motion was made by Johnson, seconded by Falconer to change from 45 hours to 25 hours at \$32/hour beginning January 1, 2024. Upon roll call vote, voting aye was: Falconer and Johnson; voting nay: Achterberg, Sundberg, Mutziger, and Rowbotham. Motion Failed. Motion was made by Mutziger, seconded by Johnson to change from 45 hours to 30 hours at \$32/hour beginning January 1, 2024. Upon roll call vote, voting aye was: Falconer, Achterberg, Mutziger, and Johnson; voting nay: Sundberg and Rowbotham. Motion Carried.

Homecoming will be held during the week of September 25th for the Arlington Cardinals, and they are asking for a burning permit for the burning of the "A" on Monday, September 25th on the school grounds. Motion was made by Achterberg, seconded by Johnson to approve this permit if there are personnel from the fire dept on scene during this event. All in favor-Carried.

The Chamber of Commerce requested an area to put a shed that they will be selling raffle tickets on. The Council approved them putting the shed to the west of the city/fire/ambulance building where Marshal approves – back far enough not to impede the vision for traffic.

Electric Report – Marshal gave the Council a quote on a ³/₄ ton short box pickup that the Electric department could use and then the existing Electric Department pickup would replace the white flatbed pickup that has some issues. Also, there will be 4 lights on Birch Street that will have the structure/base work completed before the dirt work/grass planting is completed.

Motion was made by Achterberg, seconded by Johnson to approve the Overtime and Police report.

The Council reviewed the Revenue, Expense, Cash and Utility Reports. Some discussion was held about the water leak that was found and repaired – the numbers should look better next month as part of the month still had the leak, plus there was hydrant flushing.

Mayor's Report – the Mayor asked the Council if they wanted to continue mowing the east end of Hickory (past Adams)

Consensus was to mow it and be sure the survey posts stay as they are put now.

Additional items: Fall City Cleanup is set for Thursday, October 12th. The Diatsu is very old, and Marshal is getting pricing for a replacement vehicle (side by side and others).

Motion was made by Achterberg, seconded by Falconer to go into executive session at 9:55 PM for possible litigation. Mayor Lundquist declared out of executive session at 10:01 PM.

Motion to adjourn was made by Falconer, seconded by Johnson. All in favor-Carried.
